Empowering Sustainability: The Role of Transition Finance in India's Net-Zero Vision





Examining Transition Finance's Goals, Range, and Credibility

At the United Nations Climate Change Conference (COP28), transition financing is a major area of concern. There are increasing requests for agreement and clarification on this crucial component of the net-zero conundrum. Among other things, representatives from the public and commercial sectors will be meeting in Dubai next week for COP28 to "endorse a roadmap for rapidly developing and implementing common definitions of the transition finance strategies needed lar as capital that can enable to unlock global finance in sup- high-emitting businesses and/ port of net-zero commitments. Given that a lack of agreedupon definitions and methods is frequently cited as impeding the adoption and legitimacy of transition finance, this might be a significant development in the

The need for transition finance is growing. In the past ten years, green financing has increased over a hundredfold, but we still need more momentum to get net zero. To facilitate their transformation, other vital sectors of the economy particularly those with high emissions and difficulty abating them will need to make large investments. Due to a lack of established guidelines and accountability systems, this type of funding is sometimes contentious and has been accused of greenwashing. The international community must quickly define, valorize, and implement transition finance to guarantee





the magnitude and speed of financial flows necessary for a fair and orderly net zero transition.

Goal of Transition **Finance**

Transition finance is now broadly defined as "investment, financing, insurance, and related products and services that are necessary to support an orderly, real-economy transition to net zero," according to the Glasgow Financial Alliance for Net Zero (GFANZ). Nonetheless, a lot of frameworks concentrate on transition finance in particuor hard-to-abate industries to decarbonize.

We believe that this distinction is essential. Markets and taxonomies already exist for climate solutions (batteries, solar panels, etc.) that qualify for green finance; nevertheless, capital and investment are also needed to decarbonize the rest of the global economy. For example, Citigroup estimated that reaching net zero in the steel, cement, road freight, aviation, and shipping sectors might cost as much as \$1.6 trillion. Financial markets that can sustain pivotal moments, generate impetus for comprehensive economic transformation, and curtail greenhouse gas emissions at their origin are essential. Transition finance, when used responsibly, can offer transition-enabling solutions to high-emitting counterparties

and assets that might not otherwise be eligible for green financing. So how do you decide which counterparties, who emit a lot and/or are difficult to abate, should be able to receive transition finance?

Several papers accessible to date suggest that transition finance should be made available for issuers and/or businesses where a realistic road to 1.5°C-aligned decarbonization exists. A significant challenge, meanwhile, is what to do with entities, sectors, and assets that do not have plausible 1.5°C paths, but whose decarbonization is nonetheless necessary to meet climate targets (e.g., ending flaring and lowering methane emissions from upstream gas extraction). Furthermore, the transition trajectories of various sectoral and regional contexts vary, so any attempt to construct a universal definition must balance concerns about justice and fair share without losing the degree of ambition.

In summary, transition finance plays a crucial role in facilitating economic transitions and preventing carbon lock-in, which arises when companies, assets, or infrastructure with high carbon emissions "perpetuate, delay, or prevent the transition to low-carbon alternatives." Therefore, in addition to thorough monitoring and ex-post verification, definitional talks will also need to consider the lifetime of the activities and time horizons in credible 1.5°C climate scenarios to ensure that transition money is not being done as business as usual. Simultaneously, definitions must include appropriate transition safeguards to support impacted communities and workers while reducing adverse fects. It will essential provide further tails on how this works practice to guarantee that transition financing is "just transition finance."

Fueling India's Net-Zero Goals Through Transition **Finance**

India is currently undergoing an energy transition that is critical to the planet's health and future. In the global fight against climate change, environmental degradation, and disruptions to sustainable development, India is a leader in these complicated concerns. India's burgeoning economy and growing population are expected to cause its energy needs to triple in the next decades. The nation's particular problem is striking a balance between the rapid economic growth required to guarantee the welfare of its 1.4 billion people and its aggressive clean energy

Significant obstacles still exist, though, such as fluctuating commodity prices, bankrupt electrical distribution corporations, an unreliable supply of electricity, and growing threats to energy security. It will be necessary to close knowledge gaps in a number of the energy transition domains to establish the ideal environment for a transition that is inclusive and pro-people. These will then guide attempts to close current regulatory and policy gaps.

A compilation that delves into the complex terrain of India's energy transformation process is called Powering India's Future: Towards a People-Positive Energy Transition. Creating a Net Zero Future with Transition Finance

Nowadays, when the world is on the point of collapsing, business as usual isn't enough. History has consistently demonstrated that at some point, something fresh and more important will disrupt all business models. The sustainability revolution requires businesses to re-evaluate and realign their approach to the tor finance for its transition to United Nations Sustainable De-

velopment Goals (SDGs). To accomplish the SDGs by 2030, poor countries need to find \$4 trillion in fresh cash annually, according to UNCTAD's World Investment Report 2023. Of this, poor nations must find an annual budget deficit of \$2.2 trillion to make the switch to sustainable energy. This is where innovative approaches to financing the energy transition, or transition finance, might contribute to the goal of a net zero future.

Transition finance may allow for a true shift towards decarbonization for the sectors of the economy that currently contribute significantly: hydrocarbons, mining and minerals, coal-fired power plants, steel, cement, aviation, and so on. It may also make it possible for the private sector to produce adequate returns. Institutional investors and the private sec-

tor have the means to facilitate a long-term shift. According to the World Economic Forum, by 2030, shifting to an economy that values nature may produce over \$10 trillion in revenue and around 400 million new employment. Above all, it can help the public sector by way of public-private collaborations in blended financing.

India has unquestionably made great progress toward sustainability in addressing environmental issues like climate change. The National Clean Energy Fund, the Reserve Bank of India's first Sovereign Green Bond, the adoption of reporting guidelines for Business Responsibility and Sustainability Reports (BRSR), the expansion of green financing by SEBI, and, more recently, the Securities and Exchange Board of India (Credit Rating Agencies) (Amendment) Regulations, 2023, which set guidelines for ESG rating providers, are just a few of the initiatives that are furthering India's commitment to the shift towards a greener world.

India confronts significant challenges in obtaining private seca low-carbon economy. Many barriers contribute to these challenges, including the absence of a clear definition for transition activities, which can result in the adoption of "greenwashing" tactics. Furthermore, not enough information is disclosed regarding the sustainability and environmental impact of investments. Furthermore, there are still few cutting-edge financial instruments available that are specially made to aid in decarbonization initiatives. To raise private sector funding for India's shift to a greener economy, several issues must be resolved.

The assistance of capital markets is crucial for a sustainable transformation. One option for financing this investment is through green bonds, sustainability-linked bonds, or theme bonds, which can help India reach its 2030 objective of 500 GW of renewable energy ca-

Ashutosh Kumar had allegedly taken 'Learn Boys Hostel and Play School' in Patna on rent from where the Economic Offence Unit of Bihar Police had recovered half-burnt question papers of the National Eligibilitycum-Entrance Test (Undergradu-

The CBI has found that Ashutosh Kumar knew the premises were being used for providing question papers to NEET aspirants, officials said.

According to an FIR registered on May 8 by the Godhra police, the racket was unearthed after the Panchmahal district collector received a tip-off that some people were involved in malpractices linked to the exam.

Since the tip-off was received in advance, authorities prevented malpractices at the centre (Jay Jalaram School in Godhra) and the exam was conducted without a hitch, the FIR stated.

Besides recording the statements of the three NEET-UG candidates on Thursday, CBI officials also quizzed their parents and Dixit Patel, the owner of Jay Jalaram School, an official said. The school run by Patel was one of the centres of the NEET[1] UG exam on May 5.

SC notice to NTA seeks reply on coaching center and students' plea on NEET-UG exam



he Supreme Court asked The National Testing Agency (NTA) to apprise it whether there is any time limit for raising grievances regarding the OMR sheets provided to the candidates who appeared in NEET-UG 2024

A vacation bench of Justices Manoj Misra and SVN Bhatti, which issued notice to the NTA on a fresh plea filed by a private coaching centre and a few NEET candidates, tagged the petition with the pending matters and listed it for hearing on July 8.

Senior advocate R Basant, appearing for the coaching institute and the candidates, submitted that a few students, who have appeared for the examination, have not got the OMR sheets. The bench at the outset pointed out to Basant how a private coach[1]ing institute filed an Article 32 petition in the Supreme Court and what kind of fundafor the NTA submitted that the OMR sheets have been upload- Manoj Misra and SVN Bhatti, ed on the website and given to the candidates.

The bench asked him whether there was any time limit for raising the grievance of OMR sheets. The NTA counsel said that he needs to take instructions and seek listing of the petition along with the pending matters. "We will file a short reply by then to the query," he said. Basant pointed out that there is no set procedure or time limit to raise the grievance and therefore as an interim relief the candidates are seeking a grant of OMR sheets. The bench then issued notice and tagged the petition with the pending matters while asking the counsel for NTA to file a short written reply to the court's query on the time

On June 20, the top court sought responses from the Centre, the NTA and others on a slew of petitions, including in those seeking the scrapping of the National Eligibility cum Entrance Test-Undergraduate (NEET-UG) 2024 and a court-monitored probe, amid mounting outrage over alleged irregularities in conducting the all-India medical entrance test.

UPSC moots Aadhaar-based authentication & AI CCTV surveillance to prevent cheating

mid ongoing controversies Linvolving alleged irregularities in NEET and NET exams, the Union Public Service Commission (UPSC) has decided to implement advanced technology solutions to enhance the integrity of its examination process. The UPSC plans to use facial recognition and Artificial Intelligence (AI)--based CCTV surveillance systems to prevent cheating and impersonation during its various tests.

The UPSC, a Constitutional body responsible for conducting 14 major exams, including the prestigious civil services examination for IAS, IFS, and IPS officers, has recently issued a tender inviting bids from experienced public sector undertakings. The tender outlines two key technological solutions: "Aadhaar-based fingerprint authentication (or digital fingerprint capturing) and facial recognition of candidates, along with QR code scanning of e-admit cards," and "Live AI-based CCTV surveillance service.'

According to the tender document dated June 3, 2024, the UPSC emphasizes the importance of conducting examinations in a free, fair, and impartial manner. The commission aims to utilize the latest digital technology to verify and crosscheck candidates' biometric details and monitor their activities during exams to prevent cheating, fraud, and impersonation.

The implementation of Aadhaar-based fingerprint authentication and facial recognition is designed to strengthen the examination process. The selected service provider will use data provided by the UPSC to authenticate candidates' identities and conduct facial recognition during the exams. The process will involve a real-time attendance monitoring system, incorporating GPS coordinates and timestamps to ensure enrolment occurs within the stipulated timeframe.

The facial recognition amination. will involve a stateless transaction of two images: one provided during online registration and the other captured on the exam day. The UPSC has also decided to implement a comprehensive CCTV/ video surveillance system with recording and live

broadcast capabilities to monitor activities at exam centers nationwide

The service provider will be required to install an adequate number of CCTV cameras in each classroom, entry/exit gate, and control room where sensitive examination materials are handled. Specifically, there should be one CCTV camera for every 24 candidates, ensuring zero blind spots and continuous monitoring of all exam areas. The AI-based video system will generate alerts for any unusual movements, furniture arrangements, camera tampering, or inactivity of invigilators, raising red flags for potential cheating or unfair practices. The bid submission deadline is July 7, with the opening scheduled for the same day at 1:30 pm.

This development by the UPSC comes as the Central government faces scrutiny over alleged irregularities in the UGC-NET and NEET-UG exams, conducted by the National Testing Agency (NTA). The Central Bureau of Investigation (CBI) is currently investigating allegations of malpractice in both exams. The UGC-NET determines eligibility for Assistant Professors and Junior Research Fellowships, while NEET-UG is a critical medical entrance ex-

NEET-UG is conducted by the National Testing Agency for admissions to MBBS, BDS, AYUSH and other related courses in government and private institutions across the country. This year's exam was conducted on May 5 at 4,750 centres in 571 cities [1]ies, including 14 abroad. Over 23 lakh candidates appeared for the test. The first CBI FIR was registered on Sunday, a day after the ministry announced it would hand over the probe into the alleged irregularities in the con[1]duct of the exam to the central agency.

Student priorities on environmental issues

From 2021 to 2023, there was a noticeable increase in the importance students placed on their institution's environmental policies when choosing where to study. Importance scores rose from 79% to 84% in UK universities, and from 76% to 78% in non-UK universities.

This change is likely driven by heightened media coverage of climate events and a rising consciousness around environmental impacts, but the evidence from the ISB adds to the existing anecdotal narrative, indicating a significant shift in the importance students place on environmental issues.

Diverse perspectives based on nationality and age

The data also reveals that students from countries more di-

rectly affected by climate change, such as Pakistan and India, place greater importance on environmental policies, suggesting a correlation between personal experiences with climate impacts and environmental prioritization.

Interestingly, the data contradicts the assumption that younger students are the most environmentally conscious. Instead, older student groups (ages 30-49) showed higher concern for environmental issues. This indicates that while younger students recognize the importance of environmental issues, they might prioritize other factors more heavily in their decision-making process.

Student satisfaction with environmental efforts

Between 2020 and 2023, there was a significant increase in student satisfaction regarding their institutions' sustainability efforts. In the UK, satisfaction rose from 89% to 95%, and in non-UK universities from 90% to 92%.

Despite high overall satisfaction rates, some variability was observed across different regions and countries, with universities in European countries generally showing slightly lower satisfaction levels.

Future directions

As environmental sustainability continues to gain prominence in international education discussions, the role of data, such as our own ISB data, and collaboration among educational institutions and organizations like CANIE and the International Education Sustainability Group becomes increasingly important. Understanding and addressing the specific sustainability concerns of diverse student populations will be crucial for universities aiming to lead in the climate change discourse.
